

Ashok Kumar Gupta (Manager) to verify the compliance of the shortcomings issued by this office vide letter No. F6/DFS/MS/CGHS/SZ/2020/2225 dated 08/09/2020 and observed that the shortcomings are still not fully complied.

In view of the above, application for renewal of fire safety certificate cannot be considered at this stage. You are advised to submit para wise compliance of the shortcomings for further action in the matter.

Subject: - Renewal of Fire Safety Certificate in r/o Welcome Group CGHS Ltd. Plot No.6 Sector-3 New Delhi

Sir,

This is in reference to your email dated 11.08.2020 on the subject cited above. In this connection it is to inform you that the above said residential building has been inspected by the officers concerned of this department on 29.3.2020 in presence of Sh. Nishith Sexena (Secretary) & Sh. J.C Maihotra (Treasurer), Sh. Amrit Sagar (Safety & Security) to check the fire safety systems as per Guidelines issued by this department vide letter no. F6/DFS/MS/BP/155 dated 9.1.2013.

During the course of inspection following shortcomings have been observed:-

1. Width of internal road for fire tender movement all around the building is 5.20 to 6 Mtrs. against the requirement of clear width of 6 mtrs. & turning 7 Mtrs. against requirement of 9 Mtrs.
2. Width of staircases is 1.19 & 1.15 Mtrs. against the requirement of 1.25 Mtrs.each.
3. Fire check doors removed at some points in lift lobbies at basement floor.
4. One ABC Fire Extinguisher is provided at each floor against requirement of two at each floor.
5. Shut off Nozzles are missing in some hose reels.
6. MOEFA is provided but not functional.
7. P.A. System found removed.
8. Some hose boxes near yard hydrants are damaged/broken.
9. A Terrace pump 1800 LPM capacity is provided at each block but not on auto operation.
10. Draw off connection is damaged.
11. Illuminated exit signs not displayed at some points.
12. Fire Hydrant & hose reel not extended at community hall.

In view of the above shortcomings Fire Safety Certificate cannot granted. You are advised to rectify the above shortcomings under intimation to this department for taking further necessary action.
