Introduction

The Department of Information Technology, Government of NCT of Delhi, is committed to promoting the adoption of Artificial Intelligence (AI) and emerging technologies to enhance governance, improve citizen services, and drive innovation across sectors.

In this regard, the Department invites Expressions of Interest (EoI) from technology companies, startups, academic institutions, research organizations, and industry bodies to showcase their Artificial Intelligence (AI) based products, solutions, projects, and use cases relevant to public service delivery and governance.

The objective of this initiative is to identify innovative AI solutions that can potentially be adopted or piloted across departments of the Government of NCT of Delhi.

1. Areas of Interest

Organizations are invited to submit AI-based solutions in (but not limited to) the following sectors:

- Smart Governance & Public Service Delivery
- Urban Planning & Smart Cities
- Environment & Air Quality Monitoring
- Health and Digital Health
- Transport and Mobility
- Education

2. Eligibility

a) The following entities are eligible to participate:

- Technology companies and AI solution providers
- Startups working in AI/ML technologies
- Academic and research institutions
- Industry associations and innovation labs
- System integrators and technology consulting firms

b) AI Solution must be commercially available and done at least one successful implementation, relevant to public service delivery and governance (Domestic/International).

3. Submission Requirements



Interested organizations should submit a **brief solution note/presentation** containing the following details:

1. Organization profile
2. Description of the AI solution/project
3. Technology stack used (AI/ML models, data platforms etc.)
4. Use cases and demonstrated outcomes
5. Deployment status (pilot / production / research stage)
6. Relevance to governance or public sector applications
7. Potential benefits for Government departments
8. Any previous government implementations (if applicable)

4. Mode of Showcase

Based on the submissions received, selected organizations may be invited to:

- Present their AI solutions before the AI Solution Evaluation Committee or Department of Information Technology, GNCTD
- Demonstrate live products/use cases
- Participate in AI innovation showcase / workshops / technology sessions

The Department may facilitate interaction with relevant Government departments to explore the potential for pilot deployments or future adoption.

5. Important Disclaimer

- This Expression of Interest (EoI) is intended only for the purpose of identifying and showcasing AI-based solutions and use cases relevant to government service delivery.
- Submission of EoI or participation in the showcase does not guarantee award of any work, contract, or project to the participating organizations.
- It is proposed that, wherever considered appropriate, selected organizations may be requested to undertake a limited Proof of Concept (PoC) or demonstration of their AI solutions in consultation with the concerned departments. Such PoC/demonstration shall be carried out by the participating organizations on their own resources and shall not involve any financial commitment or liability on the part of the Government of NCT of Delhi. The PoC exercise will be purely exploratory in nature and shall not be construed as award of work or commitment for future engagement.
- Any future engagement, or procurement of AI solutions by the Government of NCT of Delhi shall be undertaken strictly in accordance with the applicable Government procurement policies, rules, and procedures, including open and competitive processes as prescribed under the relevant financial and administrative guidelines.
