IMPORTANT NOTE: 1. Only physically received applications will be entertained, i.e. through Post or by hand submission in FSL. Incomplete applications shall stand summarily rejected. No correspondence will be entertained in this regard. Separate application for separate Division with supporting documents will only be considered. Application received from the applicant passed M.sc from any recognized University or affiliated College/Delhi Govt. Universities/Central Universities Located in Delhi will be entertained. All the essential documents needed to be furnished along with the application form.

2. Mode of Selection: Interview

3. Scope of work: This program would offer recent young professionals in the field, the opportunity to gain practical experience and learn about the latest techniques and technologies in Forensic Science such as forensic Biology, Ballistics, Chemistry, Cyber Forensic, Fingerprint Analysis, DNA analysis and Crime Scene investigation at the Scene of Crime etc.

4. Fixed stipend amounting to Rs. 30,000/- (Thirty Thousand only) per month will be paid.

Applications are invited from eligible candidates for engagement of M.sc passed interns on **stipend** basis for a **period of one year**.

TERMS AND CONDITIONS OF INTERNSHIP:-

1. Applications shall be invited from the eligible candidates possessing requisite qualifications as prescribed in the table in their respective desire of Division.
2. All the aspirants are requested to submit the application forms along with requisite documents to the Head of Office, Forensic Science Laboratory, Rohini Sec-14, Madhuban Chowk, New Delhi-110085 either physically or by registered/speed post on or before **10/11/2025** upto 05:00 PM.
3. The engagement shall be on "stipend basis" for a period of one year and a Fix stipend amount of Rs. 30,000/-(Thirty Thousand only) will be paid per month. No other allowances shall be admissible/paid.
4. The applicant shall not exceeding 27 years or below the age of 21years as on the last date of submission of applications.
5. Age relaxation for candidates belonging to the SC/ST category and for OBC category will be applicable as per prevailing Govt. rules.
6. Reservation policy of the Govt. of India will be considered for selection of Interns in various categories.
7. List of candidates shortlisted for Interview will be displayed on the Notice Board and official website of FORENSIC SCIENCE LABORTORY, GNCT of Delhi.
8. The candidates appearing for the Interview should bear the cost of travelling and stay under their own arrangement. No TA/DA will be paid under any circumstances.
9. In case interview cannot be completed on the scheduled date/duration, the interview shall be conducted on the next working day. Applicants are advised to

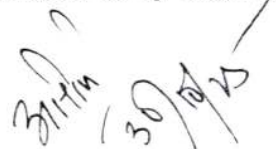

10. Candidates are required to bring original documents with self - attested photocopies of degree/certificate/ testimonials and other relevant documents on the day of Walk-in-Interview. Candidates are also required to bring any Identity proof along with self - attested copy i.e. Driving License / Voter I Card / Aadhaar Card / Bank pass book with photograph duly attested of any Nationalized Bank (at least 3 years old) / pass port or any other proof deemed fit by this office.
11. No correspondence or personal enquiries on telephone shall be entertained.
12. The names of selected candidates will be displayed on the Notice Board and official website of FORENSIC SCIENCE LABORTORY, GNCT of Delhi. No postal /personal intimation will be sent to the candidates. The candidates must be ready to join after the selection.
13. In the event of engagement, the candidate shall have to submit an undertaking stating that he/ she shall not stake any claim nor file any court case for regularization of service in any Court of Law.
14. The selected candidates shall have to execute an engagement agreement accepting the above terms and condition on a non-judicial stamp paper of Rs.100/- before their appointment on contract basis.
15. The Head of Department (FSL), Govt. of NCT of Delhi can terminate the internship at any time without notice on the following grounds:
 - a) Unauthorized absence of continuous five working days.
 - b) If at any stage, it is known that candidate have secured the internship by misrepresenting or suppressing any fact.
 - c) If found to be responsible for any act of indiscipline or misconduct or of moral turpitude or criminal acts or found to be engaged in any unlawful activities.
 - d) In case of failure to give one-month prior notice, the candidate will be liable to refund one month's stipend paid to him/her.
16. The intern can be posted at various Divisions of FSL or on Mobile Forensic Vans at the sole Discretion of Pr. Director and shall be required to work 24 X 7 in shift manner.
17. Intern may be allowed 8 Casual Leave and 2 Restricted Holidays in a Calendar year or proportionally of tenure thereof. No earned leave, medical leave or any other kind of leave will be permitted. Stipend shall be deducted in proportion to no. of days of absence, if more than 10 days leave are availed by intern.
18. Number of seats in the Divisions are tentative and may be revised as per the directions of Pr. Director/HOD FSL.

19. JURISDICTION OF DISPUTE:

The courts at Delhi/New Delhi shall have the exclusive jurisdiction to try disputes, if any, arising out of this agreement between the parties.
